



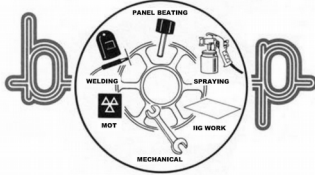

Introduction

The event will consist of normal trials sections. The event should appeal to anyone who has previously entered our Production Trials or those new to Trials and any road car should be suitable.

This event is a round of the 2020 ASWMC Car Trials Championship and the BP Motor Cotswold Motor Sport Group Car Trial Championship. **Drivers and passengers now require a Motorsport UK clubman RS competition licence which is free.** We recommend applying for the licence before the day. Unfortunately we have had to increase the entry fee to £15 to cover the increase in permit fees charged to the club by Motorsport UK. It is still one of the lowest cost events of this type.

IMPORTANT NOTE: If you intend to enter on the day please contact the Secretary and provide contact details in case wet weather causes any issues with access to the field.

Supplementary Regulations

1. The Bristol Pegasus Motor Club will organise a Clubsport status Car Trial on the 26th of April 2020 at Lower Grove Farm, Highridge Road, Dundry, Near Bristol.
Map Reference 554½ 673½ **Post Code BS41 8JT**

2. The meeting will be governed by the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting code of the FIA), these Supplementary Regulations, and any written instructions that the organising club may issue for the event.

3. The following Motorsport UK Permit has been issued.

Clubsport Event 117588

ASWMC CAR TRIALS Championship – Championship Registration Number 3/2020.

BP Motor Bodybuilders & Engineers CMSGCC Car Trial Championship promoted on behalf of the AWMMC.

4. The Clubsport event is open to all fully elected members of the Bristol Pegasus Motor Club, and all fully elected members of the following clubs:

The Bristol Motor Club

The Classic and Historic Motor Club

The Cotswold Motorsport Group Competitors Club

MGCC (South West Region)

plus registered contenders in the ASWMC Car Trials Championship 2020 and the CMSGCC Car Trial Championship promoted on behalf of the AWMMC.

5. All entrants must produce a valid membership card for either the promoting club, one of the invited clubs or, in the case of championship contenders, a membership card for a member club of the regional associations. **Drivers and passengers now require a Motorsport UK clubman RS competition licence which is free.** We recommend applying for the licence before the day - <https://www.motorsportuk.org/get-started/2020-rs-clubman-licence/> Licence application forms will also be available on the day.

6. The programme of the meeting will be as follows: Signing on and Scrutineering starts at 12-00. Any competitor not signed on by 12-45 may be EXCLUDED. The first car will start at 13-00.

7. Public roads will not be used to link sections. There will be at least 6 tests on private land. Each competitor will have at least two attempts at each test. Details of the tests will be issued at signing on. The entry may be split into groups starting on different sections.

8. The event will consist of five classes as follows:

1 Front engine, front wheel drive production cars without additional ballast.

A sump guard weighing no more than 10 kg, including fittings, may be fitted.

2 Front engine, front wheel drive production cars with ballast.

3 Front engine, rear wheel drive production saloons and production sports cars.

4 Rear engine rear wheel drive production cars.

5 Kit cars & Specials

The organisers may add additional classes or merge classes in line with the entries received.

Entries of vehicles with four wheel drive will not be accepted. Commercial type vehicles may run in the appropriate class. All vehicles must comply with Motorsport UK Technical Regulations, and must be fitted with an effective a silencer.

9. Awards will be presented as follows:

1st in each class with at least 4 starters - an award.

2nd in class with at least 8 starters - an award.

Best Bristol Pegasus Member on class index - The Cross Trophy Cup plus an award.

No competitor may win more than one award.

The Cross Trophy Cup is the property of, and will be retained by the Bristol Pegasus Motor Club.

10. The entry list opens on publication of these regulations and closes finally on 26th April 2020.

The entry fee for the event is £10 in advance or £15 on the day.

All entries must be made on the official entry form and accompanied by the appropriate fee.

12. The maximum entry for the meeting, including reserves, is 40. The minimum is 15. The maximum for each class is 20 and the minimum is 4. Should any of the above minimum figures not be reached, the organisers have the right to either cancel the meeting or amalgamate classes, as necessary. Entries will be selected at the discretion of the organisers. Entry fees may be refunded if the entry is withdrawn and notice given in writing to the secretary of the meeting, at least 24 hours before the event is due to start.

14. Provisional results will be published by despatching a copy in writing by post/e-mail within 7 days of the event.

15. Any protest must be lodged in accordance with C 5.1 to 5.7.

16. Competitors will be identified by numbers or score cards which will be provided by the organisers.

17. Marks will be awarded for completion of each section correctly as appropriate. Details of marking and penalties will be issued at signing on.

18. In respect of T 4.1 the requirement for the passenger seat to be occupied will not be a requirement for this event. Passengers are allowed but not required.

All other General Regulations of Motorsport UK apply as written.

In particular, note T 4.1.11

"Bouncing' will be Permitted only within the confines of the seating compartment, and then only so long as no portion of either the Driver's or Passenger's body, other than arms and hands, is placed outside the sides of the car or behind the seat they are occupying."

This will be strictly enforced by all marshals, and where appropriate penalties will be awarded in accordance with T 7.5.

19. For the Cross Trophy Performance on Index will be calculated in line with T7.3 and T7.4

20. Awards will be presented at the BPMC Annual Prizegiving. Uncollected awards will be available at the following years event.

Indemnification

I declare that:

1. I have been given an opportunity to read the General Regulations of the Motorsport UK and, if any, the Supplementary Regulations for this event and agree to be bound by them.  2. To the best of my belief the driver(s) possess(es) the standard of competence necessary for an event of the type to which this entry relates and that the vehicle entered is suitable and roadworthy for the event having regard to the course and the speeds which will be reached.
 3. The use of the vehicle hereby entered is covered by insurance as required by the law which is valid for such part of this event as shall take place on roads as defined by the law.
 4. I understand that should I at any time of this event be suffering from any disability whether permanent or temporary which is likely to affect prejudicially my normal control of the vehicle, I may not take part unless I have declared such disability to the ASN which has, following such declaration, issued a licence which permits me to do so.
